### **TILE DRAINAGE ISSUE ON SAUBER ROAD:**

Tom Huddleston has completed the tile survey of the area around Sauber Road. He found many of the tiles to be damaged or plugged causing the flooding that the residents have been experiencing. The Kane County Forest Preserve has agreed to fix the tiles that are on their property. Campton Excavating won the bid and will be starting the repairs shortly. Stage 2 will then commence, replacing the tiles running along Sauber Road. Kane County Highway Department has agreed to pay a portion of the bill to remove the tile from the road. President LeBlanc suggested applying for a River Boat Grant Fund to cover the cost of replacing the tiles. The residents of Sauber Road seemed to be very pleased with the projected repairs. Tom Huddleston will be working closely with John Peters as the projected repairs will impede on his property.
