PUBLIC COMMENT: Several residents inquired about the Chip 'N Seal project in Virgil View, voicing concerns about loose gravel and inquiring about the need for the project.

President LeBlanc stated that the Village's engineering firm of over 20 years (Baxter & Woodman) had been engaged to inspect the roads and provide us with solutions as to the maintenance and improvement. The Chip "N Seal option was the most fiscally responsible way to proceed at \$130,000. Out of that, \$71,000 was for patching alone. A total replacement would have cost \$425,000. If the village had done nothing, the life expectancy of the road was 3-5 years. With the Chip "N Seal, the life expectancy was increased to 7-10 years which allows the village to plan for the total repaving. President LeBlanc also offered to inquire about "fogging' (placing a thin layer of tar over the road" to see if this would help with the gravel and the resident's concerns over it.

President LeBlanc stressed the fiscal responsibilities of these decisions including the upcoming replacement of the IC Trail bridge at \$1.1mil. Even with grant money, the Village will still be responsible for \$200K-\$300K of the cost.

Residents also inquired why they were not notified of the second phase of the Chip 'N Seal project and President LeBlanc advised the letter was all ready to go but the dates were cancelled/postponed twice and the Village was not advised of the third date until the project was underway.

Residents also inquired when drain tiles were being cleaned out and President LeBlanc advised that this should not be necessary with the new set-up unless there is a blockage.

An inquiry was made regarding the replacement of the village signs and President LeBlanc explained that we are looking into a more permanent replacement of the posts to prevent the wooden posts rotting
