Presidents Report – December 14, 2023

- Tornado Sirens Working with Midwest Warning Systems a firm that refurbishes and installs warning sirens. I am meeting with them next week Wednesday and hope to have a quote by the January Board meeting. I saw a quote they did for Lily Lake and it was under \$3000 to have it installed on the fire stations roof. Not sure what a pole installation would be. Still, very reasonable.
- 07N088 Sauber Road Working with owner to continue to clean up his property of miscellaneous vehicles, construction debris, and stored equipment. After talking to Alex, the zoning prohibits the parking, or storage of any commercial vehicle over one ton anywhere on the property, inside, or out. So, he would have to move all his vehicles either off-site, or apply for a variation. I will pursue this after the holidays.
- 6N221 Meredith Road The process with the Dumdie's is ongoing. Baxter & Woodman had noted five deficiencies in their Storm Water Permit submittal. I discussed with the engineers and we agreed that two of the five really didn't apply, but required the permit to be updated with the other missing three items. As of Monday, Dec 11th, Baxter & Woodman have still not received the needed information to move forward. After the holidays we will be giving the Dumdies a strict timeline that needs to be met, or they will be cited.
- Noise Complaint on IC Trail Per the Village attorney, I have been told to stop working with resident & farmer about a noise complaint. After Alex discussed the situation with the resident's attorney, he stated that this is no longer a Village issue and that the two parties would have to come to an amicable agreement with each other, or pursue a legal solution.
- **SafeBuilt** Our local representative I will get together after the holidays so they have a better idea of what we need, how to quote/cost that model, and how to move forward. Hopefully I will have an update at the January meeting.
- Baxter & Woodman IC Trail & Welter Road. Our representative has taken pavement core samples to determine the make-up of both roads and their respective bases in order to formulate the best path forward for repair/replace. Currently they are concentrating on manhour estimates for survey and drainage design to reestablish functional ditches along both. This needs to be done before any remediation of the pavement occurs as water has been a factor on the deterioration of both roadbeds.
- **Boundary Agreements** Both Lily Lake & Burlington are looking to update their respective boundary agreements with the Village and they suggest we relook at our boundary agreement with Elburn as well.
