# Presidents Report – Aug 8<sup>th</sup>, 2024

 July 15<sup>th</sup> Storm – Worked with ComEd, Kane County Highway Department, and Kane County Office of Emergency Management to get debris removed from Village roads as well as timing of power resumption in all sections of the Village. Did it help with me sending out updates as I received them?

#### Citations:

- 07N088 Sauber Rd Making progress resident is slowly cleaning things up and clearing out older vehicles.
- 47W504 IC Trail Mr. Brummel was a no-show at the hearing. Fines started at \$25 a day. That changed to \$50 a day on 8/3 and will further increase to \$100 a day on Sept 2. He currently owes \$525.
- 6N221 Meredith Road –contractor is on-site and has started the bioswale and drain on property. Once done, Baxter & Woodman will inspect, Dumdies will pay what they owe the village, and they will receive their permit.
- Kane County Forest Preserve Forest Preserve Board is to approve our intergovernmental agreement Tue 8/13 allowing me to get a contractor on-site to install a 550ft underground cable from IC Trail to the installation site as well as install a transformer pad at the site. Once done, ComEd is about 9-10 weeks out for installing power to the site.
- Braniff Communication/Tornado Siren the siren and all the supporting
  equipment has been received from Federal Signal and is waiting in Braniff
  Communications warehouse for an installation window once power has been
  brought to the site. We will pay for all the equipment today and the installation
  services once installation is complete.
- Police I would like to sign up with the Kane County Sheriff to receive a focused two hours of patrols per week. I have asked for more information, but I believe it would cost \$360 per week. Please let me know your thoughts.
