- At this time, funding is the main topic
- They will be undertaking a feasibility study (paid for by the State of IL)
- The widening of the portion in Kendall County is going ahead (Sugar Grove and heading south), as well as the portion from I-90 to Plank Rd.
- Lots of funding is needed due to the train tracks and major roads.
- Rte 47 going through Lily Lake and Elburn are major issues.
- Anderson Blvd is an option (the roadbed was designed to withstand truck traffic) but they will first need a traffic light at Rte.38/Anderson to avoid traffic accidents.
- These are all preliminary talking points only.
- Re-routing Rte.47 to the west of Elburn has been scrapped, there are too many feasibility issues regarding the quality of the ground (too wet) etc.

PUBLIC COMMENT:

- Resident O'Brien asked what we could use the \$61,000 in our Grant Fund for.
- This grant was received in the 1990s from the State for Nicor coming into the village.
- A discussion was had but no specific plans were made.
- Treasurer Ruf suggested she could put those funds into a CD to get a better interest rate and the board agreed.

They are currently waiting for ComEd to disconnect power from the building, then work should commence. He should have final plans for review "soon" as he is waiting on engineering to finish some updates.
